- A) The information submitted for verification of seed / sod eligibility represents the total amount of seed or sprigs used and only this verified eligible source was used for planting the fields described on this application.
B) That all equipment involved in planting, harvesting, conditioning, or other handling of these crops is cleaned to maintain purity of the crop.
C) That the identity of the crop will be maintained from harvest time to the time it leaves my possession through use of an identification system to fulfill the growers' responsibilities as stated in the Standards for the Certification of Turfgrass, Section 1.C., Circular 15.
D) That the land which this crop is planted on meets the land requirements specified for "Vegetatively Propagated Turfgrass" in the Arkansas Certification standards in Circular 15.
